- 2. The quoted rates shall include the bidder's cost towards insurance, packing & forwarding, transportation, installation and delivery charges in the consignee places.
- 3. Supply & Installation will be made at different location of the State as per the consignee list placed at **Annexure-III**.
- 4. Each bidder shall submit only one bid, alternative bid or any conditional offer shall not be accepted.
- 5. The rates quoted by the bidders shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
